Rick Asaturian made the motion, seconded by Suzanne Sanders to approve the Agenda. Motion carried 5-0 with all voting yea.

Suzanne Sanders made the motion, seconded by Rick Asaturian to approve the minutes of the May 4, 2015 special meeting(s), copies attached. Motion carried 5-0 with all voting yea.

Andy Morgan recognized guests and visitors that were present. Dorothy Ryall, 8th grade student, addressed the Board regarding the importance of the Unity Point social worker teaching communication skills to all students and the need for additional staff assistance in this area.

Suzanne Sanders made the motion, seconded by Tom Upton to accept the resignation of Karen Frick effective end of the 2014-15 school year. Motion carried 5-0 with all voting yea.

Rick Asaturian made the motion, seconded by Suzanne Sanders to approve the 2015-16 Board of Education calendar of board meeting dates, per attached. Motion carried 5-0 with all voting yea.

Discussion was held concerning the Unity Point student residency policy.

Lori James-Gross presented the current enrollment report, per attached.

Discussion was held concerning class sizes and staffing needs for the 2015-16 school year, especially in 2nd grade where projected class sizes are expected to be high. The administration is considering collapsing two junior high math classes into one class and transferring one junior high teacher into a second grade classroom. It was the consensus of the Board to direct the Superintendent to move forward with this process.

Kerry Glenn presented information concerning the need for a technology teacher for the 2015-16 school year, especially with the new PARCC testing requirements and the retirement of the librarian in December 2015. It was the consensus of the Board to post for the technology teacher position.

A motion was made by D.W. Presley, seconded by Suzanne Sanders to award student accident insurance to Gerlock & Associates for the 2015-16 school year. Motion carried 5-0 with all voting yea.

Rick Asaturian made the motion, seconded by D.W. Presley to approve the Intergovernmental Agreement with ROE #30/COPE School for the 2015-16 school year. Motion carried 5-0 with all voting yea.
