### **2015 ISBE Financial Profile**

\*Attached for Board review is a copy of the "School District Financial Profile" which is the instrument developed by the ISBE to help monitor the finances of school districts and identify which are in or are moving toward financial difficulty. Our district will be designated under the category of Financial Review when the report is released in March, based on the indicators which take into consideration the overall financial strength of the district, district expenditures compared to revenues, number of days the district could operate without additional revenues, and the district's available short-term and long-term borrowing capacity. Financial Review means that our district is in the second highest category of financial strength with a score of 3.45 out of a possible 4.00; requiring limited review or involvement by ISBE, with monitoring of potential downward trends only. Dr. James-Gross and Mr. Laser will provide further explanation at the meeting.
