IASB-IASA-IASBO Joint Annual Conference Follow-Up

*Andy Morgan and D.W. Presley attended the Triple I Conference held in November in Chicago. They will share a summary of the workshop activities and information.

Passage of Levy, Certificate regarding Inapplicability of the Truth-in-Taxation Law, and PTELL Resolution

*The preliminary tax levy was presented at the November board meeting. The district needs to levy taxes in the amount of \$1,846,000 not including the bond and interest levy assessed by the County Clerk of \$141,000 for a total 2015 levy of \$1,987,000. The district is not required to hold a Truth in Taxation hearing in December since the amount of taxes levied for 2015 does not exceed the taxes extended for 2014 by more than 5%. Please note that we are legally required to compare last year's extension of property taxes to the current year proposed levy. Because the equalized assessed valuation (EAV) of the district will not be determined until after the levy is filed, the dollar amount of the levy must be set high enough to cover the full extension amount available on each \$100 of the final district EAV. *Pursuant to the review of the Tax Levy, Certificate regarding Inapplicability of the Truth-in-Taxation Law and PTELL Resolution, the administration recommends that the Levy be approved as presented.*

Approval of Updated Board Policies and Administrative Procedures: Section 5

*Section 5 of the current U.P. board policy manual, including administrative procedures, have been reviewed and revised according to the IASB PRESS Policy services by Dr. James-Gross, Bill Laser and board members, Craig Davis and D.W. Presley. Dr. James-Gross will provide an overview of the revisions during the meeting. The administration recommends the approval of the updated policies, with exception of Section 5.185, as presented. Section 5.185 will remain on review for 60 days, then presented in February for final approval.

IASB Goal Setting Workshop---January 2016

*Dr. Patrick Rice, Field Services Director with IASB, will be facilitating a goal setting workshop during a special board meeting scheduled for January 6, 2016. The meeting will be conducted from 5:00 PM to 9:00 PM in the Unity Point library. The purpose of the workshop is to assist the board in the review of the district's mission, vision, and belief statements and to develop district level goals to provide direction in accomplishing the district's mission and vision.
