#### Presentation of Levy Resolution and Tentative Tax Levy for 2015

\*Mr. Laser will present a preliminary tax levy to the Board for review. The *Truth in Taxation Law* requires that the district determine the estimated amounts of taxes necessary to be levied for 2015 not less than 20 days prior to the official adoption of the aggregate tax levy. The administration will request that the Board approve the district's final tax levy at the December board meeting. Since the estimated tax levy for 2015 does not exceed the prior year's extension by greater than 5%, the District is not required to give public notice or conduct a public hearing.
