Approval of Updated Board Policy—7:60 Residence

*Section 7:60 of the current U.P. board policy manual was presented at the January board meeting and subsequently placed on hold to further research the Per Capita Tuition Charge (PCTC) for Unity Point. Per the 2015-2016 Annual Financial Report, the PCTC is \$7312.25. The District may charge up to 110% of this amount or \$8043.48 per student. The Board will need to discuss potential updates to the language as deemed necessary.

*The tentative Seniority List for 2016-2017 has been reviewed and amended as necessary. The list was posted in the building and given to UPEA in accordance with Illinois School Code deadline of February 1. Discussion of School Facility Tax—Next Steps

*The next J-8 Summit meeting will be held on Wednesday, February 15th at 6:30 P.M. at McElvain School in Murphysboro. The primary focus of the meeting will be to discuss the following: 1) the resolution needed to define the role of the Regional Office of Education, 2) the role of the J-8 Citizen's Group going forward, and 3) project priorities within each district. 2017 ISBE Financial Profile

*Attached for Board review is a copy of the "School District Financial Profile" which is the instrument developed by ISBE to help monitor the finances of school districts and identify which are in or are moving toward financial difficulty. Our district will be designated under the category of Financial Early Warning when the report is released in March, based on the indicators which take into consideration the overall financial strength of the district, district expenditures compared to revenues, number of days the district could operate without additional revenues, and the district's available short-term and long-term borrowing capacity. Financial Early Warning means that our district has received a score of 3.00 out of a possible 4.00; requiring monitoring and technical assistance by ISBE (i.e. financial projections and cash flow analysis). Dr. James-Gross and Mr. Laser will provide further explanation at the meeting.

Need for Tentative March 9th Board Meeting

*The administration is not recommending a reduction-in-force for the 2017-2018 school year and therefore does not have a need for the tentative board meeting scheduled for March 9, 2017. Recommendations for employment for the 2017-2018 school year will be presented at the March 23, 2017 board meeting.
