#### Approval of 2009-2010 Seniority Lists

\* The final 2009-2010 Seniority List was reviewed and amended as necessary. It was posted in the building and given to UPEA on December 7, 2009 in accordance with Illinois State Code deadline of February 1. As part of that requirement, the Board of Education must approve the final list as presented.

## FY11 Budget Reduction Scenarios

\*The state has, and continues, to experience great financial uncertainty therefore creating major concerns for all school districts and the fiscal year 2011 budget. The current state budget projection includes a \$12 billion budget shortfall. This includes the loss of ARRA funds, the debt service on this year's pension notes, and \$3 billion in delayed payments to state vendors. The State is also obligated to increase the pension payment by an estimated \$1.2 billion next year. On top of that we have just learned that State Income Tax revenue is coming in less than expected due to the high rate of unemployment, and that we are running an

additional \$900 million short of projections. Illinois is using approximately \$1 billion in stimulus funding in FY 2009 and FY 2010 for General State Aid purposes. In FY 2011, the State will have to come up with an additional \$1 billion just to maintain education funding levels. Therefore, due to the problems with the State budget, the general economic environment, and our individual budgetary concerns; it will be necessary for the district to utilize all possible funding solutions to deal with this financial crisis. Attached for your review is a draft of possible options for the Board to consider when addressing our financial situation. Dr. James-Gross will provide a detailed explanation of the options presented.

## Approval of Food Bids

\*Bids for food items for the second half of the school year (January 1 – July 31, 2010) were received on December 3, 2009. Ulli Tragoudas will present a summary of the respective bids at the board meeting. The administration recommends that the food bids be awarded to the low bid as presented.
