#### P.A. 96-0434: Itemized Salary Compensation Report for Administrators

As of August 13, 2009 school districts are now required to annually prepare an itemized salary compensation report for any employee holding an administrative certificate and working in that capacity. The report must be:

\*presented and approved by the school board at a regularly scheduled meeting; \*sent to the Regional Office of Education; and

\*posted to the school website by October 1, 2009.

The report must cover compensation paid the previous school year. The new law also requires districts to post each contract it has entered into with each employee group. Attached for your review is a copy of the itemized compensation report for the superintendent and two (2) principals for 2008-2009.
