Our district will be designated under the category of Financial Review when the report is released in March, based on the indicators which take into consideration the overall financial strength of the district, district expenditures compared to revenues, number of days the district could operate without additional revenues, and the district's available short-term and long-term borrowing capacity.

Review means that our district is in the next highest category of financial strength with a score of 3.45 out of a possible 4.00; requiring limited review or involvement by ISBE, but we will be monitored for potential downward trends.
