#### 2012 ISBE Financial Profile

\*Attached for your review is a copy of the "School District Financial Profile" which is the instrument developed by the ISBE to help monitor the finances of school districts and identify which are in or are moving toward financial difficulty. Our district will be designated under the category of Financial Recognition when the report is released in March, based on the indicators which take into consideration the overall financial strength of the district, district expenditures compared to revenues, number of days the district could operate without additional revenues, and the district's available short-term and long-term borrowing capacity.

Recognition means that our district is in the highest category of financial strength with a score of 3.80 out of a possible 4.00; requiring little or no review or involvement by ISBE unless requested by the district. The Board of Education and Mr. Laser are to be commended for their efforts in maintaining the financial health of UP. Dr. James-Gross and Mr. Laser will provide further explanation at the meeting.
