Approval of 2012-2013 Student Handbook and Athletic Handbook Revisions

*Handbook revisions have been on review since the May board meeting. The attached student handbook includes two additional updates: (1) the breakfast, lunch, and milk fees have been changed to reflect the increases approved at the May board meeting and (2) the "Grading" section (pg. 30) has been updated to reflect the change in the Junior High Exploratory classes. The exploratory classes will now be quarterly with a letter grade assigned. The assigned grade will be weighted 1 point toward the grade point average, as is P.E. Prior to this change, the exploratory classes rotated every 27-28 days and had to be bridged between quarters and was assigned a pass/fail designation. There haven't been any comments or questions relating to the updates; therefore, it is the recommendation of the administration to approve the revisions as presented for the 2012-2013 school year.

Adopt Prevailing Wage Rate Ordinance

*Pursuant to the rules promulgated by the Illinois Department of Labor, it is necessary to adopt "An Ordinance Ascertaining the Prevailing Rate of Wages for Laborers, Workmen and Mechanics Employed on Public Works for Said District" as provided by the Illinois Department of Labor.

Approve Bids Relating to the ISBE Maintenance Grant

*The bid opening was held on Wednesday, June 7th at 2:00 p.m. There were three bids for review with J&L Robinson providing the lowest responsible bid. Therefore, the administration recommends that the board award said bid to J&L Robinson (as presented) for the work associated with the ISBE Maintenance Grant that was awarded in May. All work is to be completed by August 15, 2012.

Award Bids for Bread, Milk, Food, and Diesel Fuel

*Bids were received from Interstate Brands (St. Louis), and Sara Lee Bakery (Louisville) for bread. The administration recommends that the bread bid be awarded to Sara Lee as they were the successful low bid. As in the past, Prairie Farms and Hines Oil Company were the only bids received for milk and diesel fuel. The fuel bid does contain an escalator feature, as we would expect. The price quoted for diesel fuel is \$3.2870, which is an increase over last year's price per gallon of \$2.6280. Bids for food items for the first half of the upcoming school year were received early June. Ulli has reviewed each bid, item by item, and a summary report is included for your review. The administration recommends approval of the bids as presented.
