Hunger-Free Kids Act of 2010

*Section 205 of the Healthy, Hunger-Free Kids Act of 2010 requires schools to increase their paid lunch prices to eventually "catch up" with the federal reimbursement rate for free lunches. Currently, the reimbursement for free lunches is \$2.77 and the reimbursement for paid lunches is \$.26. So, eventually (within 10 years) the price of our paid lunches has to increase to \$2.51. Therefore, we suggest the following price increases for paid lunches for the 2012-2013 school year:

STUDENTS:

Lunch: \$1.50 to \$1.75 Breakfast: \$.80 to \$1.00

ADULTS:

Lunch: \$2.00 to \$2.50 Breakfast: \$1.10 to \$1.30

*We would suggest a two-year cycle of price increases to reach the federal reimbursement level of \$2.51. Area schools are currently charging the following amounts with discussion of increasing their prices:

Giant City School:	Lunch = $$2.00$	Breakfast = N/A
CMS 95:	Lunch = $$1.50$	Breakfast = $\$.50$
DeSoto:	Lunch = $$1.50$	Breakfast = $\$.75$
Carterville:	Lunch = $$1.50$	Breakfast $=$ \$.90
Anna:	Lunch = $$1.75$	Breakfast = $$1.25$

Award Student Insurance for 2012-2013 School Year

*Gerlock & Associates, out of Carterville, is the only proposal we have received for voluntary student insurance coverage. The administration would recommend that the Board of Education approve K&K Insurance (with Gerlock & Associates) as our provider. Generally, we do have a few parents who choose to utilize this insurance. The coverage is intended to provide supplemental insurance, although some parents take the coverage as their ONLY form of insurance.

-The Individuals with Disabilities Act of 2004 requires all states to make determinations on the performance of their local districts with regard to the provision of special education and related services. The Illinois State Board of Education has reviewed our data from the 2010-2011 school year and has determined that Unity Point has received the designation of **MEETS REQUIREMENTS** in implementing one or more of the requirements of IDEA. Ms. Haar will provide further explanation at the meeting.

-Also, the special education profile is now on review with District Superintendents until May 9. Unity Point School is currently reviewing the report with Tri-County Special Education for accuracy and will suggest changes to ISBE if needed. According to the report, as it is currently written, Unity Point has met all state requirements except for the percentage of students with IEP's in separate educational facilities. Ms. Haar will provide further explanation at the meeting.
