IASB Fall Dinner Meeting Follow-Up

SB7: Mandated Training for Board Members & Formation of Joint Committee for RIF Process *Dr. James-Gross will explain the training requirements for UP board members under Senate Bill 7. Also, the board will need to appoint the representatives to serve on the Joint Committee that will determine the procedures that govern the FY12 RIF process. The board may choose the administration as their representatives to work through this process with Union membership. In order to comply with the law, the administration recommends that the Board of Education adopt the enclosed resolution determining the estimated amount of property taxes necessary to be levied for 2011, as well as establishing the need for a public hearing during the November board meeting.
