Approve Policy 5.330 – Vacation for Educational Support Personnel

*The policy revisions have been on review since the August board meeting; the administration has not received any questions or concerns regarding the policy updates. The administration recommends the board's approval of the policy as presented.

Healthy, Hunger Free Kids Act of 2010---Need to Increase the Price of Milk

*As of July 1, 2011, the Illinois State Board of Education states that all non-reimbursable meal foods (i.e. milk) that are sold by the school food service to generate revenue should be at least equal to their cost. At present, our vendor cost for a carton of milk is 27 cents. The administration recommends raising the current fee of 25 cents to 30 cents for a single carton of milk, effective October 3, 2011. The administration will send a letter to parents explaining the required increase in fees as soon as possible.

Acceptance of Application for Recognition of Schools 2011-2012

*The Board of Education must approve the district's application for recognition of schools. The Superintendent, with the assistance from the building principal, completed and reviewed the application. The administration is, therefore, requesting approval of the recognition application.

Board/Community Retreat (10/1/2011)

*The retreat is planned for Saturday, October 1, 2011 from 9:00 a.m. to 12:00 p.m. The administration will present information regarding topics that include our Program Organizational Chart and Student Support System. The retreat will be conducted in a seminar format with the opportunity for questions.
