Public Hearing---2012 Tax Levy

*The preliminary tax levy was presented at the November board meeting. The district needs to levy taxes in the amount of \$1,500,000 not including the bond and interest levy assessed by the County Clerk of \$140,000 for a total 2012 levy of \$1,640,000.

The district is required to hold a truth in taxation hearing in December since the amount of taxes levied for 2012 exceeds the taxes extended for 2011 by more than 5%. Total property taxes levied for 2012 represent an 8.11% decrease over the 2011 property taxes extended.

Please note that we are legally required to compare last year's extension of property taxes to the current year proposed levy. Because the equalized assessed valuation (EAV) of the district will not be determined until after the levy is filed, the dollar amount of the levy must be set high enough to cover the full extension amount available on each \$100 of the final district EAV.

Passage of Levy, Certificate of Compliance, and PTELL

*Pursuant to the review of the Tax Levy, Certificate of Compliance, and PTELL at the hearing which was held in accordance with State Law, the administration recommends that the Levy be approved as presented.

Presentation of FY12 Audit

*Kevin Batteau, CPA, with Kujawa and Batteau will present the FY12 audit report to the Board. Should you have any questions prior to the meeting, please contact Mr. Laser. The administration recommends acceptance of the FY12 Audit as presented.

Resolution to Place Operating Referendum on April 2013 Election Ballot
