2013 ISBE Financial Profile

*Attached for your review is a copy of the "School District Financial Profile" which is the instrument developed by the ISBE to help monitor the finances of school districts and identify which are in or are moving toward financial difficulty. Our district will be designated under the category of Financial Recognition when the report is released in March, based on the indicators which take into consideration the overall financial strength of the district, district expenditures compared to revenues, number of days the district could operate without additional revenues, and the district's available short-term and long-term borrowing capacity.

Recognition means that our district is in the highest category of financial strength with a score of 3.55 out of a possible 4.00; requiring little or no review or involvement by ISBE unless requested by the district. The Board of Education and Mr. Laser are to be commended for their efforts in maintaining the financial health of UP. Dr. James-Gross and Mr. Laser will provide further explanation at the meeting.

April 9, 2013 Referendum Update

*The UP #140 Steering Committee is hosting a voter registration night at Evergreen Terrace on Wednesday, February 13th from 6:30 to 8:30 PM. Informational flyers were sent home with students on Friday, February 8th. Door-to-door distribution of flyers will begin late February and continue into early March. Post card reminders with early voting dates/location will be mailed the week of March 18th. The steering committee is currently investigating the use of the District's alert-now messaging system as a means to communicate with parents directly before the date of the election.

Approval of Unity Point Cross Country Team

*After piloting a successful Running Club during the 2012 Cross Country season, the administration would recommend that the Board of Education approve the formal organization of a Unity Point Cross Country team. The Unity Point Booster Club has agreed to fund a \$1000 coaching stipend for the 2013-2014 season. If approved, the administration will conduct both an internal and external job posting for the coaching position. The annual cost to include a cross country team in the Southern Illinois Jr. High Athletic Association is \$60. At this time, we will utilize our older track uniforms and plan to participate in local events only. If the 2013-2014 season proves successful and the Board would plan to continue cross country, the annual stipend would need to be negotiated as part of our UPEA contract.
