Required Board Member Trainings

*To date, all board members who are required to participate in mandatory trainings have been registered for local workshops. Those board members needing to complete the training for Open Meetings Act may do so on-line. Dr. James-Gross will provide further information at the meeting.

2013 COPS Hiring Program/Grant Application

*The Jackson County Sheriff's Office is considering applying for a federal grant to partially fund a school resource officer to be shared amongst local school districts. Unity Point, Giant City, and Trico School districts have been approached about collaborating on this project. If awarded, the CHP grant would cover up to 75 percent of the approved entry-level salary and fringe benefits of each newly-hired and/or rehired, full-time sworn law enforcement officer over the three-year (36 months) grant period, with a minimum 25 percent local cash match requirement and a maximum federal share of \$125,000 per officer position. In past applications, the local match has been funded at 25% in year one, 50% in year two, and 75% in year three. If the local match were to be funded by all partners, each entity would be responsible for approximately \$4100 in year one, \$9200 in year two, and \$14,100 in year three. The fourth year of the grant would be the sole responsibility of the collaborating districts with each district contributing approximately \$20,000. The intent of the grant is to provide schools with resource officers who are expected to spend a minimum of 75% of their time working on youth-related activities, crime prevention efforts, and increasing their community policing capacity.

Should the decision be made to move forward with Unity Point's participation in the grant, the Board will need to approve the attached Memorandum of Understanding.

Approve Submission of ISBE Maintenance Grant Application (Summer 2013)

*On April 17, 2013, ISBE announced that the State is making available \$9.8 million for the School Maintenance Grant Program. The dollar-for-dollar matching grant program provides up to \$50,000 in matching funds for the maintenance or upkeep of buildings or structures for educational purposes. Applications must be submitted in partnership with the local architect to the Regional Office of Education by May 31, 2013 through the IWAS system. A meeting was held with our architect, Baysinger Design, on April 25. We discussed the potential of completing exterior brick work including sealant and roof replacement on the 1986 edition. Baysinger is currently completing cost estimates for each of the projects and will then assist in the completion of the grant application and submission of the necessary Health Life Safety Amendment. The administration is requesting that the Board of Education authorize the submission of the school maintenance application up to an amount not to exceed \$100,000.

Award Student Insurance for 2013-2014 School Year

*Gerlock & Associates, out of Carterville, is the only proposal we have received for voluntary student insurance coverage. The administration would recommend that the Board of Education approve K&K Insurance (with Gerlock & Associates) as our provider. Generally, we do have a few parents who choose to utilize this insurance. The coverage is intended to provide supplemental insurance, although some parents take the coverage as their ONLY form of insurance.
